To provide programs and support for seniors on the Key Peninsula so that they can age safely in their homes and community of choice. We utilize creative partnerships and volunteers to provide senior transportation, information and referral, enrichment programs, in-home repairs and support services. We recently completed construction of assisted living and memory care homes in Key Center for seniors unable to stay safely in their homes. We annually serve about 950 seniors delivering 6,023 instances of service during the year focusing on four priority need areas: 1) Local, centralized senior information and referral, 2) transportation and mobility options for seniors, 3) Senior health and wellness services, and 4) supportive senior housing options.
